LIMITED WARRANTY AND LIMITATION OF LIABILITY: Addmaster warrants all IJ7100 and IJ7200 Series printers against defects in material and workmanship for a period of two years from date of shipment from factory. **THIS IS A LIMITED WARRANTY LIMITED TO ITS TERMS.** This warranty is void if the product has been altered, misused, subjected to damage by modified or non-specified cartridges or third-party inks, taken apart, damaged in third-party service, dropped, damaged in transit when improperly packaged or otherwise abused. ADDMASTER'S OBLIGATIONS AND LIABILITIES UNDER THE FOREGOING WARRANTY ARE LIMITED TO REPAIR OR REPLACEMENT OF THE PRODUCT WITHOUT CHARGE WHEN RETURNED FREIGHT PREPAID TO ADDMASTER'S SERVICE DEPOT LOCATED AT 225 E.
